## **CHECK FIRST...**

  - b) Past entrants who have progressed to farm ownership within 3 years of entering (from the close of the publicised SFOTY category closing date – 5 Dec 2025).
  - Regional winners of the DMOTY category no longer eligible to enter the SFOTY category.
- Maximum of 7 years since last entry into DMOTY or SFOTY.
- NZDIA employees and trustees are not eligible. Contractors who meet the rest of the criteria are eligible.
- National Committee members are not eligible while in office, a time extension equivalent to the time spent on Committee to a maximum of 3 years will be given.
- 8. You can enter only one category run by the NZDIA in any one year.
- Shortlisted entrants and winners agree to make themselves available to the national sponsors for promotional purposes.
- All entrant details will be held by the NZDIA and may be used for promotional purposes by the NZDIA and their national sponsors.
- 11. Promotional and advertising rights are at the sole discretion of the NZDIA.
- 12. The judges' decision is final and no correspondence will be entered into.
- Winners will be required to move their business account to ASB.
- Entrants to be available to attend Nationals week (08 to 11 May 2025).
- Attend an ASB Alumni function at Mystery Creek Fieldays (Wednesday 11 June 2025).
